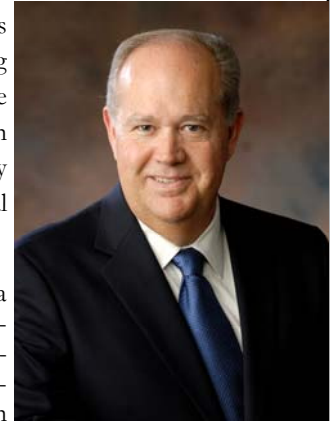




**Special Guest Speaker**  
**Randall Pope**



Randall grew-up involved in his family's farm operations. Following two years of military service, he received his Bachelor's Degree in Agricultural Business followed by his Master's Degree in Agricultural Economics.

In March 1995, Randall became a principal and partner in The Westchester Group, a national agricultural asset and investment management company headquartered in Champaign, Illinois. At that time he assumed the roles of President and Chief Operating Officer of the company. Randall is currently responsible for Westchester's new agricultural investment activity globally. Over the past three years Westchester's institutional investment business in farmland ownership has grown to encompass some one billion dollars of farmland holdings including some 250,000 acres of farmland in Australia and over 75,000 acres of farmland, both row crops and permanent crops, in the US.

Randall is a former professional member of the American Society of Farm Managers and Rural Appraisers, a former member of the AgriFinance Magazine editorial advisory board, a founder and Director of Partners for Agricultural Literacy, a frequent speaker at National Pension Fund and Agricultural Conferences and a past member of the National Agricultural Credit Committee. He is a frequent group leader at the Harvard Executive Agribusiness seminar and visiting professor at several agricultural colleges.
